### Vendor Services Agreement Parks and Recreation

This agreement is for \_\_\_\_\_\_\_\_ to do a craft display at Towamencin Day on Saturday, May 10, 2025 from 12pm to 4pm. The event will be at Fischer's Park, 2225 Bustard Rd. Lansdale, PA. You can set up from 9:00am to 11:30am. You may check in at registration, unload, and then move your car to field parking. At 11:30am we close the park to pedestrians.

1. <u>Services</u> You will provide a table, chairs, canopy, signs, hand truck, and any items for your display unless otherwise discussed. Towamencin Township will provide a 12ft wide space for displays. Feel free to buy two spaces if you need extra room.

2. <u>Payment and Terms</u> You will pay \$50.00 for a craft vendor display. Refunds will only be granted if the event is cancelled by the township due to extreme weather. No power will be offered to vendors and informational booths. Cancellation due to weather/parking will be determined on Friday, May 9<sup>th</sup> at 12noon.

3. <u>Staging</u> Towamencin Township will provide a clean and safe area for the set up and execution of your display. You will be responsible for all setting up, running, promotional materials, music, signage, hand trucks, and breaking down of equipment at your particular display.

You agree to protect any and all of their valuables in or about the property by removing them to safe storage before the staging date.

4. <u>Release and waiver</u> You further agree to release, indemnify and hold harmless Towamencin Township, its employees. Agents, contractors and suppliers against any and all losses, accidents, damages, injuries, expenses and claims resulting in whole or part, directly or indirectly, from the staging process.

5. <u>Photography and publicity release</u> You agree to allow Towamencin Township to photograph staged areas of the Event before, during, and after the work is completed and to use all such photographs for reference and marketing purposes.

6. <u>General provisions</u> Towamencin Township has the right to reject any booth or display that we feel contains lewd, salacious, racist, politically abrasive, or sexist propaganda or materials.

This agreement contains the entire agreement of the parties, and there are no other promises or conditions in any other agreeement whether oral or written.
