Consider Extension Request: Conditional Use Approval Belfair Square

At the January 24, 2024, meeting, the Board of Supervisors approved the Conditional Use Order for Caracausa Acquisitions, LP (Belfair Square). The Conditional Use permits the construction of 16 townhomes (Use R-5 - Townhouse Dwelling) with a carport in the Residential Business and Professional (RBP) Overlay Zoning District subject to the condition that the development and use

of the subject property be in accordance with the testimony and exhibits presented. The applicant has requested an extension of the Conditional Use approval to coincide with the land development approvals that run through January 24, 2029.

Developer David Caracausa shared his rationale behind the request, noting the current marketplace and interest rates have not changed significantly and he did not anticipate much change to justify shorter extensions. The Board discussed various timeframes for extensions and project updates.
