Chair Snyder called the meeting to order at 7:01 pm and led the assemblage in the Pledge of Allegiance.

**Opening Comments**

- This meeting is available live via Zoom for residents who cannot attend in person. Public comments submitted by 4:30 pm today will be read at the start of the meeting, followed by in-person comments. For in-person comments or questions, please use a microphone, as Zoom does not pick up voices from the audience.
- The Board met in executive session before the meeting to discuss personnel and real estate matters.
- Towamencin was selected for \$3 million in funding through PennDOT's Multimodal Transportation Fund (MTF) for the Welsh and Orvilla Roads Intersection Improvements Project. PennDOT noted the selection process was extremely competitive statewide, with 171 applications. This project was one of only 4 that was awarded the \$3 million maximum grant funding request. This project will address the long-standing traffic backups and challenges navigating this intersection by adding left-hand turning lanes from each approach.

**Emailed Public Comments:**

Resident Lynn Fox commented that she feels the Township's RFP for a new municipal solicitor is a significant decision with long-term financial and operational impacts, noting that legal services are among the Township's most costly professional expenses. She emphasized the

current Solicitor's institutional knowledge and the additional transition costs and billable time typically associated with changing firms. She stressed that the selection process should be transparent and based on objective criteria such as qualifications, experience, cost, and demonstrated value. She raised concerns about the appearance of political influence, indicating that one applicant firm previously hosted a fundraiser for newly elected Supervisors, prompting community questions about fairness and merit. While acknowledging that political fundraising is legal, she noted that transparency is especially important when firms with prior political involvement seek Township contracts. She urged the Board to prioritize stability, continuity, public trust, and to avoid any selection that could create the appearance of a conflict of interest.

Resident Rory Kelley congratulated the newly elected Supervisors and expressed appreciation for prior leadership and collaboration. He emphasized the need to move beyond campaign politics and encouraged the Board to work together and prioritize residents over partisan considerations. He referenced past community unity around the sewer sale issue and noted the value of maintaining that spirit of collaboration independent of political involvement. He urged all five Supervisors to work together on behalf of all residents, regardless of voting history, and expressed cautious optimism about the Board's ability to govern effectively.

#### **In-Person Comments:**

Resident Casey Hannings congratulated the two new Supervisors. He implored the Board to leverage any available provisions in the Township code to protect open space and to work with the developer to ensure habitat protection and alleviate traffic concerns. He believes there are additional ways to further protect grasslands.

Resident Barry Kenyon congratulated the new supervisors and reminded them of their campaign promises of transparency, accountability and financial responsibility. He said with the pending Solicitor RFP, the supervisors should recuse themselves if any applicant is a firm that funded their campaign. He said this is about transparency and public confidence, and that they need to uphold what they ran on because residents are watching. He said the law firm in question was also the firm that guided the Government Study Commission. He said this law firm could cost the Township double the current Solicitor fees and insinuated an established relationship between the supervisors and that law firm.

Resident Joe Silverman stated that he paid a visit to Montgomeryville's Harbor Freight because he was unaware that Towamencin's Harbor Freight had opened. He encouraged folks to check out what the store has to offer. He feels they have things many people can use.

Resident Bruce Bailey thanked the Board and Township staff for their support of Bird Town and the Committee. He noted that the Bird Town Committee is hosting an event this Saturday and encouraged kids to come out to participate in building birdhouses and other activities. He then asked the Board to investigate the fee the developer can pay in lieu of open space. He noted he believes the existing ordinance is from the late 1990s and indicated these fees should reflect the current economic climate. He is pleased to hear that Dock purchased a farmhouse on Tomlinson Road, adding he feels Dock is an excellent steward of the land in the Township. He then thanked Joe Meehan for all his contributions to the Township through the committees he serves on and for his attendance at many Township meetings. Lastly, he gave a shout-out to the Township Police Department for all their efforts.

#### **Public Hearing: Lighting Ordinance Amendment**

The Township's Environmental Advisory Council recommended revisions to update the lighting standards within the current ordinance. Notable revisions will require LED fixtures, modify the maximum height for certain lights, and require full-cut-fit fixtures. The proposed revisions will help to minimize glare and reduce light pollution. The Township Engineer reviewed the proposed amendment and had no concerns with the changes. The ordinance amendment was advertised as required.

The Township Solicitor opened the hearing and reviewed the related exhibits. Mary Stover, Township Engineer, reviewed the amendments. A court reporter was present to make a complete and formal record of the hearing.

Supervisor Warner asked if the Ms. Stover saw any negatives resulting from these changes. Ms. Stover indicated no.

Resident Casey Hannings applauded the efforts to reduce light pollution.

Resident Joe Silverman thinks this is a great idea and referenced a presentation he gave at a previous public meeting.

Resident Joe Meehan asked for clarification on the ordinance number. Solicitor Iannozzi confirmed it is #26-01.

#### **Authorization to Advertise: 2026 Road Paving Program**

Bid documents are being prepared for a contract associated with the Township's annual repaving program. 16 roads are scheduled for milling and paving this year. Curbs and handicap ramps for these roads were upgraded in 2025. An awarded contract is anticipated to be announced this spring, with paving scheduled during the summer months to reduce conflicts with school buses.

Roads scheduled for 2026 paving include: Amber Lane, Kindle Drive, Buckboard Way, Carriage Way, Tapestry Way, Misty Meadow Lane, Jacks Circle, Green Bank Way, Spring Mill Way, Old Dutch Road, Kareve Drive, Reinhart Road, Breman Road, Burgandy Way, Pheasant Hill Way and Metz Road.

Supervisor Osei asked which parts of Kriebel were included. Chair Snyder indicated that Kriebel is not listed, but rather Kareve. Township Engineer Mary Stover noted that Kriebel was previously considered but was removed after review.

#### **Authorization to Advertise: 2026 Concrete Project**

This bid is for a contract associated with the Township's annual curb ramp upgrades and concrete curb replacements. Per PennDOT and Federal regulations, when projects, such as road resurfacing are undertaken, the municipality must upgrade existing pedestrian curb ramps to the latest ADA standards. This contract will also involve property owner concrete replacements, including curbing, driveway depressions and aprons. The ramp work included will be for roads scheduled for paving in 2027. Four handicap ramp locations are included in the project.

Roads affected include: Quarry Road, Reiff Road, Adams Road and Sunset Way.

### **Additional Business**

Supervisor Warner noted that some Township representatives attended the County's recent orientation forum for municipal leaders and shared noteworthy information, including:

1. The County offers free property alerts for suspicious activity. When there's an occurrence, the property owner would be notified, i.e. someone attempts to forge documents regarding their property.
2. Veterans can sign up with the County to receive free ID cards, which provide discounts for numerous places across the County.
3. The County has a Veterans Trail with a map that describes where Veteran monuments and memorials are located throughout the County. She noted she did not see any Towamencin locations and would share the map with Mr. Meehan to provide feedback on whether any Towamencin locations should be included.

There being no additional business, the meeting was adjourned at 7:40 pm.
