Event Participant Services Agreement Parks and Recreation

This event will be held at Fischer's Park, located at 2235 Bustard Road, Lansdale, PA 19446. Please arrive by 8:30 AM and promptly check in at registration. Parking will be available for all registered cars in the paved parking lot. Spectators must park in the field adjacent to the paved parking lot.

1. Payment and Terms. A \$20.00 fee will be collected per car. Refunds are only granted if the event is canceled by Towamencin Township due to weather concerns, park conditions, or unforeseen circumstances. Cancellation due to unforeseen circumstances will be determined by Friday, September 11th, at 12 PM.

3. Staging. Towamencin Township will provide a clean, safe venue for the event. I agree to safeguard all my valuables on the property. I understand that alcoholic beverages are strictly prohibited.

4. Release and waiver. I further agree to release, indemnify, and hold harmless Towamencin Township, its employees, agents, contractors, and suppliers against any and all losses, accidents, damages, injuries, expenses, and claims resulting in whole or part, directly or indirectly, from participating in this event.
