☐ I understand and am aware of the following fee(s) for obtaining a solicitor's permit:

- The fee for a solicitor's permit is **\$100**, payable by **cash, check or money order** made out to Towamencin Township Police.
- There is no fee for non-profits and charitable organizations.

☐ I understand that permits are valid for **30 days**. After 30 days, my permit will expire and I **must** repeat the application process, including submitting new a background check and paying the applicable fees, if I am to continue to solicit within Towamencin Township.

☐ I understand that solicitor permits are non-transferable, may not be used by anyone else, may not be used to solicit in neighboring townships and must be carried on my person and provided when asked.

☐ I understand that failure to provide valid documentation or providing documentation containing erroneous information may result in delay or denial of my application.

Failure to adhere to township ordinances may result in immediate revocation of solicitation privileges for you and the company you are representing, as well as facing possible citations issued to you and your company by Towamencin Township Police.
